Regular meeting of the Council of the City of Ottawa, Illinois.

Commissioner Eichelkraut presented minutes of previous meetings.

Moved by Commissioner Eichelkraut that the minutes of a regular meeting of the Council of the City of Ottawa, Illinois, held on Tuesday, July 3, 2018, and the minutes of a special meeting held on Thursday, July 12, 2018, both be approved as recorded in the permanent files of the City Clerk.
