Previous meeting (April 8, 2014) minutes were read by Secretary Bangert. Motion made by <u>Jock Brown</u>, second by <u>Greg Elliott</u>, to accept the meeting minutes. By acclimation, the motion carried unanimously.

Financial Report (April, May, and June 2014) was read by President Donahue. Motion made by <u>Jock Brown</u>, second by <u>Greg Elliott</u>, to approve the April, May, and June 2014 financial reports. By acclimation, motion carried unanimously.

Old Business:

President Donahue acquired the pension board trustee term dates from city hall.

Robert Paglis spoke to the board about current national governmental and financial viewpoints regarding small pension board funds consolidation with oversight by a paid third party and the perils of such for small well funded systems.

New Business:

There was a brief discussion regarding changing our re-investment of annual dividends within some of the Edward Jones portfolio (approx. \$150,000). Due to the amount, no action was taken by the board.

Motion by <u>Jock Brown</u>, second by <u>Greg Elliott</u>, to ratify payment to the Illinois State Treasurer in the amount of **\$3,109.74** for Illinois Department of Insurance compliance invoice. By accliamtion, motion carried unanimously.

President Donahue was reimbursed **\$1,030.93** for actual expenses of the I.P.P.F.A. Spring Conference.

Charles Rice passed away 5/30/2014. His pension at the time of death was \$2,003.38 / mo. Payment will continue to his widow, Elizabeth Rice, in the amount of \$2003.38 / month for the remainder of her life with health insurance deductions as follows:

July 2014 - \$626.02 (will continue until 2015)

No tax deduction was selected
