Discussion:

- 1. Chapter IV, Section I of the current Rules and Regulations, and Article XIX, Section 19.3 of the current Firefighter collective bargaining agreement require that "All examinations for promotion shall be competitive among such members of the next lower rank as desire to submit themselves to examination."
- 2. His rank at the beginning of the promotional examination process is a Firefighter, not Lieutenant.
- 3. Pursuant to the current Rules and Regulations Chapter IV, Section I, and Article XIX, Section 19.4 of the current Firefighter collective bargaining agreement "The order of testing shall be as follows: (1) Professional Achievement, (2) Seniority, (3) Merit and Efficiency, (4) Oral Interview, and (5) Written Examination."
- 4. He has no experience at the lower rank
- 5. It is not possible to evaluate his performance as a lieutenant for this promotional examination process.
- 6. He would have no professional points to submit to the Board at the oral interview at the rank of lieutenant.

Moved by Ken Brown, second by Steve Malinsky to reject Firefighter Barry Russell's request to test for the captain exam due to ineligibility. All ayes. Motion passed.
