Calvin and Ruth Leason 1806 Chestnut: weeds and garbage have never been cleaned up behind the truck dock fence; bottom of north ditch is too steep for a mower and not been maintained, during plowing ripped up edge of the roadway. Don and JoAnn Jones 1711 Walnut Street: boarding up windows has helped and looks better, outside lighting has helped and pipe at the northwest corner of their property flows the wrong way.
