- 2. No His rank at the beginning of the promotional examination process is a Firefighter, not Lieutenant.
- 3. Pursuant to the current Rules and Regulations Chapter IV, Section I, and Article XIX, Section 19.4 of the current Firefighter collective bargaining agreement "The order of testing shall be as follows: (1) Professional Achievement, (2) Seniority, (3) Merit and Efficiency, (4) Oral Interview, and (5) Written Examination."
- 4. <u>He has no experience at the lower rank</u>
- 5. It is not possible to evaluate his performance as a lieutenant for this promotional examination process.
- 6. He would have no professional points to submit to the Board at the oral interview at the rank of lieutenant.

The Board approved the fire promotion score compilation with the scores provide by Chief Borkowski for the merit and efficiency, professional achievement and seniority, and the scores from the oral interviews conducted on August 4, 2018.
