CIVIL SERVICE COMMISSION MINUTES September 20, 2012

Kyle Stephens called the meeting to order at 11:00 a.m.

Moved by Phil McNally, second by Jack Mitchell to approve the minutes of the July 17, 2012 meeting as written. All ayes. Motion passed.

Moved by Kyle Stephens, second by Phil McNally to adopt the Final Telecommunicator Eligibility Register from the examination given on August 29, 2012. All ayes. Motion passed.

Discussion regarding amending the Civil Service Commission Rules and Regulations.

Mayor Eschbach requested that the Civil Service Commission consider amending sec. 2.9, (d) of the Civil Service Rules and Regulations to read:

Seasonal or temporary employees whose employment does not exceed 90 work days or 720 work hours in any calendar year.

Mayor Eschbach further requested that the Civil Service Commission consider adding co-op students affiliated with a local high school as exempt. It was determined that the State Statute does not allow the Civil Service Commission to add the exemption for co-op students.

It is proposed that the following modifications be made to the Rules and Regulations adopted on February 8, 2005 (changes are indicated with strikethroughs and underlining):

- 1.1 <u>Meeting of Commission</u> Meetings of the Commission shall be held at the office of the Commission at the call of the president or any two members. Members shall be notified and written notice of the date, time, place and object of the meeting shall be mailed to each member by the secretary, at least four two days prior to the meeting.
- <u>2.9 Exemptions from the Classified Service</u> The classification plan shall include all classes as approved and from time to time amended by the Civil Service Commission.

Not to be included in the classified service are:

- a. Officers who are elected by the people.
- b. Officers who are elected by the City Council or whose appointment is subject to approval by the City Council, i.e. City Engineer.
- c. Heads of principal departments and Divisions of the City.
- d. Seasonal or temporary employees whose employment does not exceed 90 work days <u>or 720 work hours</u> in any calendar year.
 - One private secretary and or deputy to each of the elected City officials.
- e. Administrative assistants to the Mayor.
- <u>8.3 Notification of Candidate</u> The person-(s) certified for an original entry position shall be notified by the U.S. mail, <u>email or in person</u> that he has been selected for appointment. The individual so selected must notify the Commission in writing of his intentions within 5 days of notification.
- <u>9.2 Probationary Period</u> All classified appointees shall be on probation for a period of six months <u>or a period mandated</u> <u>by a collective bargaining agreement.</u> If the conduct and performance of a person appointed has been satisfactory, the appointment shall be deemed complete unless the appointing authority extends the period.
- 11.2 Termination Proceedings The City of Ottawa shall commence all termination proceedings against an employee by filing with the Civil Service Commission written charges factually stating the causes justifying termination. A copy of the written charges shall be served on the employee by <u>registered</u> <u>certified mail or hand delivery</u>. The effective date of discharge, if ordered, will be date designated by the Civil Service Commission.

The proposed amendments will be acted upon at the next Civil Service Commission meeting scheduled for Thursday, September 27, 2012 at 11:00 a.m.
