Discussion items;

- 1. Cristal Metals Agreement formerly known as International Titanium Powder is expanding and will have an agreement before the Council on July 2, 2013.
- 2. The Flats Building Official Mike Sutfin reported that 3 houses have asbestos. Nicor is charging a \$1300.00 disconnect at the main fee. A sewer service will be moved to eliminate a lift station and the sewer will be changed to an 8" gravity line. The Wiesbrock house is still up in the air due to the "benefits cost analysis" report from the State. The Council will need to make decisions soon regarding power lines and possible removal of streets.
- 3. USEPA NPL 1 at Guion Street. USEPA is going to require an agreement be in place that we, the City, will not dig any more than 2 feet deep. The contamination is 12 feet deep. Clauses need to be added to the agreement having the EPA pay if we need to fix the water/sewer lines and do annual training at the expense of the EPA.
- 4. Peltier Glass Do we need help deciding what to do with the building? Yes. Dave will schedule a meeting.
- 5. Berry Avenue ROW triangle The City is purchasing this right of way for \$2,000.00. The area is around 800 square feet.

New Business;

Commissioner Aussem commented on getting caught up with his summer help and summer projects. He also reminded of the chain of command.

Several commented on the Central School property and having a meeting open to the public so suggestions could be taken from all in the community and the proposed future use for the open space.
